## The Birth of the Limited Liability Company

Generally, 1791 is considered the beginning of commercial companies with limited liability protection from creditors. This new type of Company greatly stimulated business development due to protection of the owners from lawsuits. Investors fled to start new companies or invest in existing ones. Incorporated companies face complex and costly Federal and State operating laws which work against individuals or small groups operating as general partnerships desiring liability protection—small business growth suffered. In 1992 this was solved by the State of Wyoming with the birth of a new form of company named Limited Liability Company or LLC was born—it immediately spread to all the states and the District of Columbia.

## **Titles**

A \$220 title processing fee will be assessed to all new titles.

Titles filled out improperly will incur a defective title fee. The fee will be fairly based upon the extra work required. Please call us prior to completing the title if you have any questions.



Due to the high volume of client mail received at our office it is necessary to institute a postage charge for mail forwarding. Action Services, LLC will charge \$1.00 for every piece of first-class mail we forward to cover the cost of postage and envelopes. We will send a billing invoice once we have forwarded 10 pieces of mail. Also, as a reminder, Action Services, LLC is not a USPS-approved mail forwarder, therefore we are unable to accept and forward any mail not pertaining to our client business relationship. Please do not ask us to forward any other type of mail.



## **Financing**

When buying an RV or any vehicle it is important to be aware that the dealer cannot always assist with financing a vehicle purchased through a corporation or limited liability company (LLC). Alternative financing is readily available from banks that do not have dealer/agent agreements. Additionally, state banks and credit unions usually finance LLC purchases.

For RV financing contact Hal Jolles at Voyager Credit 877-222-0301. Voyager Credit works with banks that allow for the LLC to be listed as the owner on the vehicle title.

## **The Client Referral Program**

The Client Referral Program is our way of saying thank you for referring new clients. It is well received and successful for both you and our firm!

Each referral of a new client earns you a credit of \$100. Your account will be credited when the new client establishes an LLC with our office. This credit can be used for payment on any charges made to your account, however, it is not payable in cash. ## **Money Transfers**

When purchasing a vehicle it may be advantageous to have the funds drawn from a Montana bank account. Our office can facilitate a wire transfer or cashier's check to assist with this. The fee for either service is \$250 or 0.1% of the transfer amount whichever is greater.



Your LLC can purchase motorhomes, cars, trucks, atvs, motorcycles, trailers, boats, etc...

## TIPS FOR PURCHASING VEHICLES

- All title work, bill of sale forms, and purchase agreements must be made out <u>only</u> in the name of your LLC (which is a resident of Montana). No personal names can be filled in as purchaser.
   When your title is assigned to your LLC and you are personally listed as a co-purchaser, the Montana DMV will <u>reject</u> it. Montana only allows residents of Montana (the LLC) to be listed on titles.
- When signing any documents on behalf of the company, sign your name as Member. Only one member is required to sign on behalf of the LLC.
- We recommend purchasing from a dealer outside your State of residence. This is to avoid the possibility of the State auditing your dealer and in turn, possibly contacting or auditing you.
- When purchasing your vehicle please make sure that you receive
  the title at the time of possession or that the dealer will mail the
  title directly to our office. We cannot apply for your Montana title
  until we have the title provided by the dealership.
- When purchasing from a private party ask the seller to let you review the title prior to making payment. Personally inspecting the title ensures that the seller owns the vehicle and has physical possession of the title. If you have any questions on the inspected title call us and we may ask that the title be faxed to us for review. This will prevent the purchase of a vehicle that is not transferrable due to erasures, incorrect signature location, etc.
- Please do not cross out, change, erase or White Out anything on your title as this may void it. If a mistake was made please contact our office and we will assist with getting it corrected.

## Permanent Registration

Montana allows for most vehicles 11 years old and older to be permanently registered.

The cost is usually about three to four times the cost of registration for one year.

The State of Montana doesn't allow for a permanent registration to be transferred to a new owner or to a new vehicle. Once the vehicle is sold the permanent registration is cancelled. Montana doesn't refund registration fees.

Trucks over one ton cannot be registered permanently.

Permanent registration can be attractive to classic car owners who wish to lower ownership costs.
